

In the 3rd quarter of 2023, the Company and its subsidiaries reported total sales revenues of Baht 618 million, a decrease of Baht 118 million or 16% from the same period last year. This comes from 2 major businesses as follows.

(1) Sales revenues from product of vegetables and fruit

Sales revenues decreased by Baht 55 million, or 24%, from the 3rd quarter of 2022, this was mainly due to the overview global economic situation and the economic activity in the USA market still slowing down and the main customers still have remaining stocks on hand from ordering in the past quarters lead to a decrease in overall export volume compared to the same period last year. As a result, overall sales revenues for the nine-month period of 2023 decreased by Baht 288 million or 34% compared to the total revenues in the same period of the previous year.

(2) Sales revenues from beverages

Sales revenues decreased by Baht 62 million, or 13%, from the 3rd quarter of 2022, this was mainly due to a decrease in export sales of fruit juice products. Moreover, the domestic market is in a downtrend. As a result, the overall sales volume of fruit juice products decreased. However, natural mineral water products continue to grow well across all channels. Therefore, the overall sales revenues for the nine-month period of 2023 increased by Baht 35 million, or 3%, compared to the same period last year.

In the 3rd quarter of 2023, the Company and its subsidiaries reported total operating expenses of Baht 713 million, a decrease of Baht 104 million or 13% compared to the same period of last year. The main reasons are as follows.

- Cost of sales decreased by Baht 66 million, in line with sales revenue decreased in the 3rd quarter of 2023. However, due to the relatively dry climate factor resulted in the quality and volume of agricultural products leading to the higher cost of raw materials compared to the same period last year. Gross profit margin has therefore decreased from 23% in the 3rd quarter of 2022 to 19% in the 3rd quarter of 2023.
- Selling and distribution expenses decreased by Baht 35 million, mainly due to a decrease in trade agreement costs, the cost of expired products, logistics, and sea freight.
- Administrative expenses decreased by Baht 4 million, mainly due to a depreciation expense for machinery in the 3rd quarter of 2022 while no such item in the current year.

Overall, for the nine-month period, the Company and its subsidiaries reported operating expenses of Baht 2,193 million, a decrease of Baht 207 million or 9% from the same period of the previous year. The main reasons are as follows.

- Costs of sales decreased by Baht 152 million in line with a decrease in sales revenue. However, raw material costs tend to continually increase compared to the same period of the previous year.
 As a result, the gross profit margin dropped from 21% in the nine-month period of 2022 to 18% in the nine-month period of 2023.
- 2. Selling and distribution expenses decreased in line with decreases in sales revenue. The main expenses come from distribution center fees, advertising, and event marketing expenses.
- Administrative expenses decreased by Baht 51 million due to a depreciation expense for the machinery of Baht 54 million in the nine-month period of 2022 while no such item in the current year.

1.3 Share of profit from investment in associate

In the 3rd quarter of 2023, the Company recognized a share of profit from investment in associate of Baht 47 million, which decreased by 60% compared to the same period of last year. On the other hand, the Company recognized a share of profit from investment in associate of Baht 486 million in the nine-month period of 2023, an increase of 58% from the same period last year.

2.1 Assets

As of 30 September 2023, the Company and its subsidiaries reported total assets of Baht 6,322 million. A decrease of Baht 217 million from total assets of Baht 6,540 million at the end of 2022 with the main reasons as follows.

- A decrease in net trade accounts receivable of Baht 131 million, which mainly came from the vegetable and fruit products business.
- Net inventories decreased by Baht 19 million, mainly from the vegetable and fruit products business.
- An increase in investment in an associate of Baht 25 million due to an increase in profit sharing from investment in an associate.

 Property, plant, and equipment net decreased by Baht from 100 million from normal depreciation for the period of Baht 168 million, In addition, to an increase from the acquisition by Baht 89 million.

2.2 Liabilities

As of 30 September 2023, the Company and its subsidiaries reported total liabilities of Baht 2,028 million. A decrease of Baht 151 million from total liabilities of Baht 2,179 million at the end of 2022 with the main reasons as follows.

- A decrease in trade and other payables of Baht 103 million, which mainly came from the vegetable and fruit products business.
- An increase in bank overdrafts and short-term loans from financial institutions amounting to Baht
 168 million is intended to be used in liquidity management within the Group.
- Long-term loans from financial institutions decreased by Baht 206 million from normal repayment as scheduled.

2.3 Shareholders' equity

The Company and its subsidiaries' equity decreased by Baht 66 million from Baht 4,361 million at the end of 2022 to Baht 4,294 million at the end of the 3rd quarter of 2023, mainly a result of

- 1. Net profit for the nine-month period of 2023 amounts to Baht 270 million.
- 2. The Company paid dividends to shareholders of Baht 338 million in the 2nd quarter of 2023.

For the first nine-month of 2023, the Company and its subsidiaries reported a net decrease in cash and cash equivalents of Baht 2 million from 3 main activities:

- 1) Net cash used in operating activities of Baht 7 million.
- 2) Net cash from investing activities amounted to Baht 396 million. The main cash flow came from dividend income from an associate of Baht 462 million.
- 3) Net cash used in financing activities of Baht 391 million, consisting of an increase in bank overdrafts and short-term loans of Baht 168 million, dividends paid to shareholders of Baht 338 million, and repayment of long-term loans from financial institutions of Baht 206 million.

The Company and its subsidiaries' gross profit margin decreased from 21% in the nine-month period of 2022 to 18% in the nine-month period of 2023. The main reason is that overall export revenue decreased while raw material costs were higher compared to the same period of last year.

EBITDA Margin increased from 16% in the nine-month period of 2022 to 24% in the nine-month period of 2023, mainly due to an increase in the share of profit from investment in an associated company by Baht 178 million or 58% compared to the same period last year. This is the same reason that both net profit margin and return on equity were higher compared to the same period last year.

Debt to equity ratio slightly decreased from 0.50 times at the end of 2022 to 0.47 times at the end of the 3rd quarter of 2023, mainly due to a decrease in long-term borrowings from financial institutions. while the shareholders' equity decreased from an increase in dividends paid to shareholders.

The liquidity ratio slightly decreased to 0.59 times at the end of the 3rd quarter of 2023 from 0.63 times at the end of 2022, due to an increase in short-term borrowings from financial institutions.
